This notice describes how medical information about you may be used and disclosed and how you can get access to this information. **Please review it carefully.** 

## Your Rights

#### You have the right to:

- Get a copy of your paper or electronic medical record
- Correct your paper or electronic medical record
- Request confidential communication
- Ask us to limit the information we share
- Get a list of those with whom we've shared your information
- Get a copy of this privacy notice
- Choose someone to act for you
- File a complaint if you believe your privacy rights have been violated

## Our Uses and Disclosures

#### We may use and share your information as we:

- Treat you
- Run our organization
- Bill for your services
- Help with public health and safety issues
- Do research
- Comply with the law
- Respond to organ and tissue donation requests
- Work with a medical examiner or funeral director
- Address workers' compensation, law enforcement, and other government requests
- Respond to lawsuits and legal actions

## Your Rights

#### When it comes to your health information, you have certain rights.

This section explains your rights and some of our responsibilities to help you.

#### Get an electronic or paper copy of your medical record

- You can ask to see or get an electronic or paper copy of your medical record and other health information we have about you. Ask us how to do this.
- We will provide a copy or a summary of your health information, usually within 30 days of your request. We may charge a reasonable, cost-based fee.

## Ask us to correct your medical record

- You can ask us to correct health information about you that you think is incorrect
  or incomplete. Ask us how to do this.
- We may say "no" to your request, but we'll tell you why in writing within 60 days.

## Request confidential communications

- You can ask us to contact you in a specific way (for example, home or office phone) or to send mail to a different address.
- We will say "yes" to all reasonable requests.

## Ask us to limit what we use or share

- You can ask us **not** to use or share certain health information for treatment, payment, or our operations. We are not required to agree to your request, and we may say "no" if it would affect your care.
- If you pay for a service or health care item out-of-pocket in full, you can ask us not to share that information for the purpose of payment or our operations with your health insurer. We will say "yes" unless a law requires us to share that information.

## Get a list of those with whom we've shared information

- You can ask for a list (accounting) of the times we've shared your health information for six years prior to the date you ask, who we shared it with, and why.
- We will include all the disclosures except for those about treatment, payment, and health care operations, and certain other disclosures (such as any you asked us to make). We'll provide one accounting a year for free but will charge a reasonable, cost-based fee if you ask for another one within 12 months.

## Get a copy of this privacy notice

 You can ask for a paper copy of this notice at any time, even if you have agreed to receive the notice electronically. We will provide you with a paper copy promptly.

## Choose someone to act for you

- If you have given someone medical power of attorney or if someone is your legal guardian, that person can exercise your rights and make choices about your health information.
- We will make sure the person has this authority and can act for you before we take any action.

## File a complaint if you feel your rights are violated

- You can complain if you feel we have violated your rights by contacting us using the information on page 1.
- You can file a complaint with the U.S. Department of Health and Human Services Office for Civil Rights by sending a letter to 200 Independence Avenue, S.W., Washington, D.C. 20201, calling 1-877-696-6775, or visiting www.hhs.gov/ocr/privacy/hipaa/complaints/.
- We will not retaliate against you for filing a complaint.

## Your Choices

For certain health information, you can tell us your choices about what we share. If you have a clear preference for how we share your information in the situations described below, talk to us. Tell us what you want us to do, and we will follow your instructions.

#### In these cases, you have both the right and choice to tell us to:

- Share information with your family, close friends, or others involved in your care
- Share information in a disaster relief situation
- Include your information in a hospital directory

If you are not able to tell us your preference, for example if you are unconscious, we may go ahead and share your information if we believe it is in your best interest. We may also share your information when needed to lessen a serious and imminent threat to health or safety.

# In these cases we *never* share your information unless you give us written permission:

- Marketing purposes
- Sale of your information
- Most sharing of psychotherapy notes

#### In the case of fundraising:

• We may contact you for fundraising efforts, but you can tell us not to contact you again.

# Our Uses and Disclosures

#### How do we typically use or share your health information?

We typically use or share your health information in the following ways.

**How else can we use or share your health information?** We are allowed or required to share your information in other ways – usually in ways that contribute to the public good, such as public health and research. Help with public health and safety issues	<ul> <li>We can share health information about you for certain situations such as:</li> <li>Preventing disease</li> <li>Helping with product recalls</li> <li>Reporting adverse reactions to medications</li> <li>Reporting suspected abuse, neglect, or domestic violence</li> <li>Preventing or reducing a serious threat to anyone's health or safety</li> </ul>
Do research	• We can use or share your information for health research.
Comply with the law	<ul> <li>We will share information about you if state or federal laws require it, including with the Department of Health and Human Services if it wants to see that we're complying with federal privacy law.</li> </ul>
Respond to organ and tissue donation requests	<ul> <li>We can share health information about you with organ procurement organizations.</li> </ul>
Work with a medical examiner or funeral director	<ul> <li>We can share health information with a coroner, medical examiner, or funeral director when an individual dies.</li> </ul>
Address workers' compensation, law enforcement, and other government requests	<ul> <li>We can use or share health information about you:</li> <li>For workers' compensation claims</li> <li>For law enforcement purposes or with a law enforcement official</li> <li>With health oversight agencies for activities authorized by law</li> <li>For special government functions such as military, national security, and presidential protective services</li> </ul>
Respond to lawsuits and legal actions	<ul> <li>We can share health information about you in response to a court or administrative order, or in response to a subpoena.</li> </ul>

#### **Our Responsibilities**

- We are required by law to maintain the privacy and security of your protected health information.
- We will let you know promptly if a breach occurs that may have compromised the privacy or security of your information.
- We must follow the duties and privacy practices described in this notice and give you a copy of it.
- We will not use or share your information other than as described here unless you tell us we can in writing. If you tell us we can, you may change your mind at any time. Let us know in writing if you change your mind.

## **FINANCIAL POLICY**



Thank you for choosing Primary Care Providers of Chicago. S.C. (PCP of Chicago) as your healthcare providers. We are committed to your health and well being. Please understand that payment of your bill is part of facilitating your treatment. Your understanding of our financial policy is important to our professional relationship.

Our financial policy is as stated:

- All copays are due at the time of service (where applicable)
- Payment in full at the time of service if uninsured or non-contracted. If you are unable to make full payment at the time of service a financial arrangement must be signed.
- We accept cash, checks, Visa, MasterCard, Discover and American Express
- Any returned check fees charged by the bank for any reason will be chargeable to the patient.

#### **INSURANCE**

We accept Medicare assignment, as well as Blue Cross and numerous other plans. It is the patient's responsibility to cover any co-pays or deductibles as stated by your insurance provider. PCP of Chicago will submit all claims to your insurance provider as a service to you. Claims submitted to the insurance company that have been denied or remain unpaid past 30 days will be submitted to the patient for payment.

**Unauthorized, Non-covered or Out of Plan services**- I understand that if my insurance does not consider any service ordered a covered benefit I will be fully responsible for payment to PCP of Chicago. I also acknowledge that in the case of an Out of Network Plan, services may have reduced benefits and a larger co-payment/co-insurance will be required by me.

#### **HEALTH INSURANCE CLAIM FORM RELEASES**

This serves as authorization for the release of any medical or other information necessary to process claims from Primary Care Providers of Chicago. I authorize payment of medical benefits to the undersigned physician or supplier for services described on the medical claim form.

### NO SHOW/CANCELLATION POLICY



Thank you for choosing Primary Care Providers of Chicago. S.C. (PCP of Chicago) as your healthcare providers. Our goal is to provide quality medical care in a timely manner. In order to do so, we have had to implement a cancellation and no-show policy. This policy enables us to better utilize available appointments for our patients in need of medical care.

#### **CANCELLATION OF AN APPOINTMENT**

In order to be respectful of other patients' needs, please call our office 24 hours prior to appointment if you are unable to attend your appointment. The time will then become available for someone who is in need of treatment.

#### **NO-SHOW POLICY**

A "no-show" is a missed appointment that was not canceled in advance. No-shows inconvenience other patients who need access to medical care.

No-show or short notice cancellation (within 24 hours) for a scheduled appointment will result in a fee of \$50 for office visits.
